## Get Involved in Rapid Transit Planning Efforts in Your Community

We would like to announce the establishment of Rapid Transit System (RTS) Corridor Advisory Committees (CACs) in Montgomery County. These committees are part of the Montgomery County Department of Transportation's (MCDOT) and the State of Maryland's commitment to developing a Bus Rapid Transit (BRT) System in Montgomery County. These CACs will focus on the corridors currently funded for study (see page 3).

These committees will provide community stakeholders (corridor residents, businesses, churches, community organizations, and institutions) the opportunity to participate in the RTS planning process. By working with engineers, architects, land use professionals, and planners, committee members will advise MCDOT and the State in the decision process related to:

- General corridor concept designs
- Study assumptions
- Transit access and operations
- Coordination with other modes
- Public involvement planning
- Community needs

Four major corridors in Montgomery County will be studied over the next two years. The four corridors will be divided into seven segments, which will each be assigned to a CAC. Each committee will have up to 40 members.

**Nominations will be accepted until November 21, 2014.**



## **MISSION STATEMENT TO GUIDE RTS/BRT CORRIDOR CACs**

- Give community participants the opportunity to provide input to all planning and design;
- Provide the opportunity to discuss study assumptions and methodologies;
- Fulfill County Council requirements for transparency and community involvement;
- Provide the opportunity for interaction and information sharing among directly impacted residents/communities, property owners of businesses/institutions, transportation agency representatives, and transportation system users;
- Study and address potential community impacts in a comprehensive manner that leads to cost effective and context and community sensitive implementation outcomes; these outcomes should minimize negative impacts, so that quality of life is maintained for local and corridor residents;
- Serve as a clearinghouse for sharing of timely and accurate information on the studies and plans in each corridor; and
- Provide leadership and build consensus within the community to coalesce diverse interests and address stakeholder issues.
