Description: This project supports safe and accessible pedestrian facilities, sidewalks and bicycle paths. There are currently 57 miles of missing sidewalks. Due to funding constraints, the goal in FY 2013 is to complete sidewalk projects currently in progress and implement new projects as funding allows. Sidewalk projects are programmed throughout the City based on their rating under the Sidewalk Prioritization Program and petitions submitted by residents in support of their construction. Speed Camera funding, when available, is used to partially fund this project. Explanation of impact: Construction of new sidewalks will add \$1,000 to the FY 2013 operating budget for maintenance, snow removal, signs and landscaping and \$400 each year beginning in FY 2014.

Schedule: Prior year work to be completed — Install sidewalks on Anderson Avenue, Avery Road, Monroe Street and Wootton Parkway. FY 2013 — Design and construct new sidewalks identified through the Sidewalk Prioritization as funds allow. FY 2014 through Future Years — Specific sidewalks to be determined.

Status: Implementation. This project first appeared in the FY 2006 CIP. Funding Note: A portion of the revenue generated by the Speed Camera Program is dedicated to this project. A Federal Grant under the Safe-Routes-to-School Program was awarded for \$100,000 in FY 2010.
